'InstaPoints' Rewards Program by InstaReM PTE Ltd., Group Entities and Affiliates– Terms & Conditions

The InstaPoints Reward Program is operated by InstaReM PTE Ltd's group entities *and its affiliates* ("InstaReM, we, us or our"). By participating in our Rewards Program, you agree to these Terms and Conditions. These Terms and Conditions ("Terms") apply to the InstaPoints Rewards Program offered by InstaReM to our individual consumer client(s) ("Client"), and are in addition to and not in derogation of the Terms and Conditions mentioned in the User Agreement, Privacy Policy and other Policies of www.instarem.com.

each individually a "Party" and together, the "Parties".

Definition:

In these Terms and Conditions, the following words and phrases shall have the meaning set below, unless the context indicates otherwise, and may be modified from time to time.

- InstaPoints serves as a reward program for Client(s) of InstaReM where the Client(s) earns points upon signing up, and upon transactions, referrals and other activities as defined below, through www.instarem.com. [InstaPoints program is valid on or after 11th March 2018.](#)

How can InstaPoints be earned?

1. InstaPoints can be earned as a joining bonus at the time of signing up on www.instarem.com.
2. If a Client(s) signs up using a referral link or referral code, the 'Referrer' and 'Referee' each earn InstaPoints upon a successful referral where the 'Referee' is required to sign up and transact successfully through www.instarem.com for both parties to be eligible for the referral bonus.
3. InstaPoints can also be earned upon successful transactions, subject to the transfer amount meeting the minimum amount requirement for earning InstaPoints.
4. InstaPoints values are defined at www.instarem.com/instapoints.

How can InstaPoints be redeemed?

1. InstaPoints can be redeemed as a discount on the base currency / sending currency.
2. A user(s) can redeem exactly 100 - 400 InstaPoints per transaction.
3. Unless a coupon code has an InstaPoints reward associated with it, redemption of coupon code and InstaPoints on a single transaction is prohibited.

3. InstaReM may add or subtract the ways to redeem InstaPoints and/or also change the number of InstaPoints redeemed for each point as and when required.
4. InstaPoints can never be transferred to physical cash and/or requested to be sent to the Client's bank accounts.
5. InstaPoints are non-transferable between different InstaRem accounts.
6. There is no maximum number of InstaPoints a Client can earn.

Annulment of InstaPoints:

1. InstaReM expressly reserves the right, at any time and *without prior notice to the Client(s)*, to add and/or alter, modify, change or vary all or in part, this Program or to withdraw the Program altogether.
2. In case of any discrepancy, the final decision would rest with InstaReM.

Expiration:

- InstaPoints earned in the Client(s) account will expire after 6 months from their date of accrual.

2. Instarem reserves the right to restrict the use of InstaPoints.

4. Instarem reserves the right to amend the InstaPoints Terms and Conditions at any time with our sole discretion.
